AN ORDINANCE INCORPORATING A PORTION OF THE NORTHEAST QUARTER OF SECTION 21, TOWNSHIP 14 SOUTH, RANGE 2 WEST, S.B.B.M., LOCATED ADJACENT TO THE NORTH SIDE OF POWAY ROAD, BETWEEN SABRE SPRINGS PARKWAY AND THE POWAY CITY LIMITS, IN THE SABRE SPRINGS COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3000 ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0410, AND REPEALING ORDINANCE NO. 0-10290 (NEW SERIES), ADOPTED APRIL 30, 1970, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That a portion of the Northeast Quarter of
Section 21, Township 14 South, Range 2 West, S.B.B.M., located
adjacent to the north side of Pway Road, between Sabre Springs
Parkway and the Poway City Limits, in the Sabre Springs Community
Plan area, in the City of San Diego, California, within the
boundary of the district designated "R-3000" on Zone Map Drawing
No. B-3792, filed in the office of the City Clerk as Document No.

769516, be, and it is hereby incorporated into R-3000 Zone,
as such zone is described and defined by San Diego Municipal Code
Section 101.0410.

Section 2. That Ordinance No. 10290 (New Series), adopted April 30, 1970, of the ordinances of The City of San Diego be and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
