AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 16067 (NEW SERIES), ADOPTED OCTOBER 23, 1983, INCORPORATING THE EAST HALF OF LOT 4, SECTION 27, TOWNSHIP 14 SOUTH, RANGE 3 WEST, S.B.B.M., LOCATED NORTH AND SOUTH OF FUTURE CALLE CRISTOBAL, NORTH OF MIRA MESA BOULEVARD, BETWEEN INTERSTATE 805 AND CAMINO RUIZ, IN THE MIRA MESA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R1-6000 ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0407.

WHEREAS, a request has been received to extend the time on Ordinance No. O-16067 (New Series), adopted October 24, 1983; and WHEREAS, Section 1 of said ordinance provided that the R1-6000 Zone would attach if a final map or maps were recorded on or before November 23, 1986; and

WHEREAS, the requested extension of time will permit the successful conclusion and implementation of the zoning pattern heretofore approved by the Planning Commission; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Section 1. of Ordinance No. O-16067 (New Series), adopted October 24, 1986, is hereby amended to read as follows:

Section 1. That in the event that the east half of Section 27, Township 14 South, Range 3 West, S.B.B.M., located north and south of future Calle Cristobal, north of Mira Mesa Boulevard, between Interstate 805 and Camino Ruiz,

in the Mira Mesa Community Plan area, in the City of San Diego, California, within the boundary of the district designated "R1-6000" on that certain Zone Map Drawing No. B-3582.2, is subdivided and a final subdivision map or maps thereof duly submitted to the City on or before November 23, 1989, and thereafter recorded, and within such subdivision or subdivisions provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of San Diego Municipal Code Section 101.0407 shall attach and become applicable to said subdivided land and the said subdivided land shall be incorporated into R1-6000 Zone, as described by Section 101.0407, the boundary of such zone to be as indicated on Zone Map Drawing No. B-3582.2, filed in the office of the City Clerk as Document No. 769532 . Said zoning shall attach only to those areas included in the subdivision map or maps recorded as provided in this section.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
