AN ORDINANCE AMENDING ORDINANCE NO. O-16649 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1986-87," BY AMENDING DOCUMENT NO. OO-16649-1, AS AMENDED AND ADOPTED THEREIN, BY CREATING NEW POSITIONS ENTITLED "BUDGET SERVICES MANAGER" AND "ORGANIZATION EFFECTIVENESS PROGRAM MANAGER"; EXEMPTING SAID NEW CLASSIFICATIONS FROM THE CLASSIFIED SERVICE; AMENDING EXHIBIT C TO SAID ORDINANCE NO. O-16649 (NEW SERIES) TO INCLUDE THE CLASSIFICATIONS OF BUDGET SERVICES MANAGER AND ORGANIZATION EFFECTIVENESS PROGRAM MANAGER; AND ESTABLISHING A SALARY RATE THEREFOR.

WHEREAS, the budget process has become more demanding and is now essentially a year-round process and in order to improve supervision and coordination of the functions related to budget analysis, preparation, and production, the Financial Management Department (055) (herein "Department") requests that new positions of Budget Services Manager and Organization Effectiveness Program Manager be created in the Unclassified Service; and

WHEREAS, the Department proposes to reclassify one (1.00) Supervising Analyst position to the newly created class of Budget Services Manager and further proposes that the existing position of one (1.00) Organization Development Supervisor be reclassified to the newly created class of Organization Effectiveness Program Manager; and

WHEREAS, the Budget Services Manager would direct a consolidated unit within the Department which would include budget analysis, management analysis, budget production, and economic research; and

WHEREAS, The Organization Effectiveness Program Manager will be responsible for formulating and administering programs related to productivity improvement, as well as directing The City's management development program, the Management Academy; and

WHEREAS, this position also has frequent contact with the City Manager's office and department directors which deal with confidential or highly sensitive matters; and

WHEREAS, it is now requested that both newly created positions be placed in the Unclassified Service; and

WHEREAS, section 117(a)17 of the Charter provides that "managerial employees having significant responsibilities for formulating or administering departmental policies and programs" may be exempted from the Classified Service by ordinance upon first having been reviewed and commented upon by the Civil Service Commission; and

WHEREAS, the Civil Service Commission reviewed this request on March 5, 1987 and has commented favorably upon the exemptions as meeting the criteria set forth in the Charter; and

WHEREAS, it is now necessary to amend the annual salary ordinance to create said position classifications and effectuate said exemption from the Classified Service; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16649 (New Series), as amended, entitled "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1986-87" be and the same is hereby amended by amending Document No. OO-16649-1, as adopted and amended therein, by creating the new classifications of Budget Services Manager and Organization Effectiveness Program Manager, to be used by Department (055) in lieu of one (1.00) Supervising Analyst position and one (1.00) Organization Development Supervisor position respectively.


Section 2. That pursuant to section 117(a)17 of the City Charter, after having been reviewed and commented upon favorably by the Civil Service Commission on March 5, 1987, the new classifications authorized herein are hereby exempted from the Classified Service and declared to be in the Unclassified Service of The City of San Diego.

Section 3. As a schedule of compensation for the unclassified positions created and added in sections 1 and 2 hereof, the salary rate set forth in Salary Rates 7.7, 7.8 and 7.9 of the Table of Classifications and Standard Salary Rates under Managerial Category C, identified as Exhibit C to Ordinance No. O-16649 (New Series), dated May 27, 1986, be and the same is hereby adopted and said Exhibit C is hereby amended to reflect the addition of said new classifications.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

O-16649 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1988-87," BY AMENDING DOCUMENT NO. 00-16649-1, AS AMENDED AND ADOPTED THEREIN, BY CREATING NEW POSITIONS ENTITLED "BUDGET SERVICES MANAGER" AND "ORGANIZATION EFFECTIVENESS PROGRAM MANAGER"; EXEMPTING SAID NEW CLASSIFICATIONS FROM THE CLASSIFIED SERVICE; AMENDING EXHIBIT C TO SAID ORDINANCE NO. O-16649 (NEW SERIES) TO INCLUDE THE CLASSIFICATIONS OF BUDGET SERVICES MANAGER AND ORGANIZATION EFFECTIVENESS PROGRAM MANAGER; AND ESTABLISHING A SALARY RATE THEREFOR.

This ordinance amends the annual salary ordinance by amending Exhibit C thereto, to add two positions entitled, "Budget Services Manager" and "Organization Effectiveness Program Manager" to be used by Department (055) in lieu of one (1.00) Supervising Analyst position and one (1.00) Organization Development Supervisor position respectively. The ordinance also exempts said positions from the Classified Service pursuant to the provisions of San Diego Charter section 117(a)17 and establishes a rate of pay for the newly established positions.
