AN ORDINANCE AMENDING ORDINANCE NO. O-16678 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1986-87 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENTS NO. OO-16678-1 AND NO. OO-16678-2, AS AMENDED AND ADOPTED THEREIN, BY APPROPRIATING THE SUM OF \$2,000,000 FROM THE UNAPPROPRIATED FUND BALANCE OF THE SEWERAGE UTILITY REVENUE FUND (41506); DIRECTING THE AUDITOR AND COMPTROLLER TO SET ASIDE, TRANSFER AND ALLOCATE THE \$2,000,000 APPROPRIATED ABOVE TO THE SEWER MAIN CONSTRUCTION PROGRAM (70492), NORTH MISSION VALLEY INTERCEPTOR SEWER, CIP NO. 43-033.0; AMENDING SECTION 2, SUBSECTION VI, ITEM 3, OF ORDINANCE NO. O-16678 ENTITLED "SEWERAGE UTILITY REVENUE FUND (41506)" TO INCREASE THE NON-PERSONNEL EXPENSE AND TOTAL BY SAID \$2,000,000.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16678 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1986-87 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Documents No. OO-16678-1 and No. OO-16678-2, as amended and adopted therein, by appropriating the sum of \$2,000,000 from the Unappropriated Fund Balance of the Sewerage Utility Revenue Fund (41506).


Section 2. That the Auditor and Comptroller is hereby directed to set aside, transfer and allocate the \$2,000,000

appropriated above in the Sewerage Utility Revenue Fund (41506) to the Sewer Main Construction Program (70492), North Mission Valley Interceptor Sewer, CIP No. 43-033.0.

Section 3. That Section 2, Subsection VI, Item 3, entitled "Sewerage Utility Revenue Fund (41506)" of Document No. 00-16678-1 and No. 00-16678-2 be and the same is hereby amended to increase the non-personnel expense and total allocated by the said \$2,000,000..

Section 4. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
