
BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, the agreement restricting use of land for the First San Diego River Improvement Project (FSDRIP) with the U.S. Fish and Wildlife Service and to carry out the terms and conditions thereof, including the execution of permit No. 84-132-AA with the U.S. Fish and Wildlife Service and Agreement Permit No. V-84-1 with the California Department of Fish and Game.

Section 2. This ordinance shall take effect and be in force thirty days from and after its adoption.
