ADOPTED ON MAY 1 1 1987

AN ORDINANCE INCORPORATING A 22.2-ACRE COMMERCIALLY ZONED AREA LOCATED ON THE NORTH AND SOUTH SIDES OF UNIVERSITY AVENUE, BETWEEN STATE HIGHWAY 163 AND PARK BOULEVARD, IN THE UPTOWN COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO THE PEDESTRIAN/COMMERCIAL OVERLAY ZONE AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0458.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 2. The provisions of Municipal Code Section 101.0458 shall be applicable to and regulate development within the area reflected on Zone Map Drawing No. B-3841 until April 1, 1988, or until the recommendations of the study of the Sears site have been implemented by the City Council, whichever first occurs.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
