ORDINANCE NUMBER O- 16861 (NEW SERIES)

ADOPTED ON MAY 11 1987

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. O-16132 (NEW SERIES), ADOPTED JANUARY 23, 1984, INCORPORATING A PORTION OF SECTION 34 TOWNSHIP 14 SOUTH, RANGE 3 WEST, S.B.B.M., AND A PORTION OF SECTION 3, TOWNSHIP 15 SOUTH, RANGE 3 WEST, S.B.B.M., LOCATED NORTH AND SOUTH OF MIRA MESA BOULEVARD, BETWEEN I-805 AND CAMINO SANTA FE, IN THE MIRA MESA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO M-LI AND M-1B ZONES, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTIONS 101.0434.1 AND 101.0435.2.

WHEREAS, a request has been received to extend the time on Ordinance No. O-16132 (New Series), adopted January 23, 1984, which provided that the M-LI and M-1B Zones would attach if a final subdivision map(s) was recorded on or before February 22, 1987; and

WHEREAS, the requested extension of time will permit the successful conclusion and implementation of the zoning pattern heretofore approved by the Planning Commission; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Section 1. of Ordinance No. O-16132 (New Series), adopted January 23, 1984, is hereby amended to read as follows:

Section 1. That in the event that a portion of Section 34, Township 14 South, Range 3 West, S.B.B.M., and a portion of Section 3, Township 15 South, Range 3 West, S.B.B.M., located north and south of Mira Mesa Boulevard, between I-805 and Camino Santa Fe, in the Mira Mesa Community Plan area, in the City of San Diego, California, within the boundary of the district designated "M-LI" and "M-1B" on that certain Zone Map Drawing No. B-3555.1, is subdivided and a final subdivision map or maps thereof duly submitted to the City on or before February 22, 1990, and thereafter recorded, and within such subdivision or subdivisions provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of San Diego Municipal Code Sections 101.0434.1 and 101.0435.2 shall attach and become applicable to said subdivided land and said subdivided land shall be incorporated into M-LI and M-1B Zones, as described by Section 101.0434.1 and 101.0435.2, the boundary of such zones to be as indicated on Zone Map Drawing No. B-3555.1, filed in the office of the City Clerk as Document No. 769535. Said zoning shall attach only to those areas included in the subdivision map or maps recorded as provided in this section.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
