AN ORDINANCE TO DELAY THE EFFECTIVE DATE OF SECTIONS 5 and 6 OF ORDINANCE NO. O-16815 (NEW SERIES) ADOPTED FEBRUARY 23, 1987 RELATING TO BUSINESS TAXES.


BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the provisions of Sections 5 and 6 of Ordinance No. O-16815 (New Series) adopted February 23, 1987 relating to the imposition of business taxes are hereby made effective as of August 1, 1987, except as provided in Section 2 of this ordinance. In the interim, any person who would have been required to pay a business tax that becomes due between June 1, 1987 and July 31, 1987 shall pay a tax equal to the tax that would have been imposed under the former provisions of Chapter III, Article 1 of the San Diego Municipal Code immediately prior to its amendment by Ordinance No. O-16815 (New Series).

Section 2. Notwithstanding the provisions of Section 1, hereof, any person who is required to pay such a tax may elect to pay the tax imposed by Sections 5 or 6, as applicable, of Ordinance No. O-16815 (New Series).

Section 3. This ordinance shall take effect and be in force on and after the thirtieth day following its adoption.

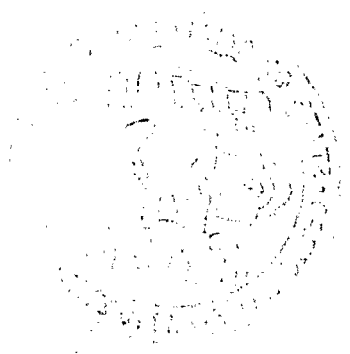


