AN ORDINANCE AMENDING ORDINANCE NO. 0-16678 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1986-87 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENTS NO. 00-16678-1 AND NO. 00-16678-2, AS AMENDED AND ADOPTED THEREIN, BY ALLOCATING THE SUM OF \$200,000 OF INDUSTRIAL DEVELOPMENT REVENUE BOND ADMINISTRATIVE BOND FUND [10240] MONIES TO THE ENTERPRISE ZONE PROJECT [NON-PERSONNEL EXPENSE]; AUTHORIZING THE EXPENDITURE OF SAID ALLOCATED FUNDS FOR DEVELOPMENT FEE REIMBURSEMENTS, CONSISTENT WITH COUNCIL RESOLUTION AUTHORIZATION CONTAINED IN RESOLUTION NO. R-262864; AND TRANSFERRING THE SUM OF \$200,000 FROM FY 1987 CDBG ENTERPRISE ZONE PROJECT [FUND 18523, DEPARTMENT 5635] TO FISCAL YEAR 1987 CDBG CONTINGENCIES [FUND 18523, DEPARTMENT 5638].

WHEREAS, in previous actions, the City Council has allocated Community Development Block Grant (CDBG) funds for the Southeast/Barrio Logan Enterprise Zone which provides for reimbursement to developers of fees paid to the City as an incentive for development; and

WHEREAS, the fee reimbursements are a part of the City's package of local incentives that were included in its Enterprise Zone application to and subsequent agreement with the state; and

WHEREAS, subsequent to Council allocations, the City was advised that use of CDBG funds for fee reimbursements would impose administrative burdens on private developers, resulting in cost increases which far exceed the City's incentives and, in

response to this problem, on December 16, 1986, the Council amended the FY 1987 budget ordinance by transferring the \$31,000 in CDBG funds budgeted for reimbursements into a different CDBG eligible project, and moving \$31,000 in sales tax funds from that project into the Enterprise Zone; and

WHEREAS, the development fee reimbursements have been both popular and costly and additional funds must be allocated to fulfill the City's intent to reimburse future development fees; and

WHEREAS, the only fund source currently available is the Industrial Development Revenue Bond Administrative Expense fund and concurrent with such allocation, the 1987 CDBG funds budgeted for this purpose would be transferred out of the Enterprise Zone into the CDBG Contingencies; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16678 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1986-87 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Documents No. OO-16678-1 and No. OO-16678-2, as amended and adopted therein, by amending the fiscal year 1987 budget by directing the Auditor and Comptroller to reallocate the sum of \$200,000 from the Industrial Development Revenue Bond Administrative Expense Fund [Fund No. 10240] to the Enterprise Zone Project [non-personnel expense].

Section 2. That the City Auditor and Comptroller be and he is hereby further authorized to expend the above reallocated funds for development fee reimbursements, consistent with and pursuant to the City Council direction and authorization set forth in Council Resolution No. R-262864.

Section 3. That the City Auditor and Comptroller be and he is hereby further authorized to transfer the sum of \$200,000 from the fiscal year 1987 CDBG Enterprise Zone Project [Fund 18523, Department 5635] to fiscal year 1987 CDBG Contingencies [Fund 18523, Department 5638].

Section 4. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
