AN ORDINANCE AMENDING ORDINANCE NO. 0-16678 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1986-87 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENTS NO. 00-16678-1 AND NO. 00-16678-2, AS AMENDED AND ADOPTED THEREIN, BY APPROPRIATING THE SUM OF \$2,124,888 FROM THE UNAPPROPRIATED FUND BALANCE OF THE SEWERAGE UTILITY REVENUE FUNDS (41506) AND ALLOCATING SAID SUM OF \$2,124,888 TO THE SEWERAGE UTILITY REVENUE FUND (41506), WASTEWATER SYSTEMS CONSTRUCTION PROGRAM (70492) FOR THE CONSTRUCTION OF THE PENASQUITOS GLENS TRUNK SEWER EXPANSION; AMENDING THE CAPITAL IMPROVEMENT PROGRAM BY ADDING THERETO A NEW PROJECT NO. 46-148.0, ENTITLED "PENASQUITOS GLENS TRUNK SEWER EXPANSION; " AUTHORIZING THE TRANSFER OF SAID FUNDS APPROPRIATED AND ALLOCATED ABOVE TO CIP NO. 46-148.0; AND AUTHORIZING THE EXPENDITURE OF SAID \$2,124,888 FROM THE SEWERAGE UTILITY REVENUE FUND (41506), WASTEWATER CONSTRUCTION PROGRAM (70492), CIP NO. 46-148.0, ENTITLED "PENASQUITOS GLENS TRUNK SEWER EXPANSION" PROJECT FOR THE PURPOSES SET FORTH THEREIN.

WHEREAS, in order for the City to meet its obligations under the "Camino Del Norte Sewer Will-Serve Agreement" entered into on September 16, 1985, certain on-site and off-site sewer facilities need to be installed and others upgraded; and

WHEREAS, the developer shall advance all costs of facilities and be reimbursed by City in a manner set forth in the proposed "Agreement Regarding Sewer Facilities;" and

WHEREAS, the City shall reimburse developer \$40,920 for on-site improvements within thirty (30) working days after their

completion and the City shall further reimburse developer 100% of the actual costs paid by developer for the design, construction and completion of off-site improvements in an amount not to exceed \$2,083,968; and

WHEREAS, funding for this project is available from the Sewerage Utility Revenue Fund 41506, Unappropriated Fund Balance; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16678 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1986-87 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Documents No. OO-16678-1 and No. OO-16678-2, as amended and adopted therein, by appropriating the sum of \$2,124,888 from the Unappropriated Fund Balance of the Sewerage Utility Revenue Fund (41506) and allocating said sum of \$2,124,888 to the Sewerage Utility Revenue Fund (41500), Wastewater Systems Construction Program (70492) for the construction of the Penasquitos Glens Trunk Sewer Expansion.

Section 2. That the Capital Improvement Program be and it is hereby amended by adding thereto a new project, CIP No. 46-148.0, entitles "Penasquitos Glens Trunk Sewer Expansion."

Section 3. That the Auditor and Comptroller be and he is hereby authorized to transfer said sum of \$2,124,888 appropriated and allocated above to CIP No. 46-148.0 and is further authorized to expend said \$2,124,888 from the Sewerage Utility Revenue Fund

(41506), Wastewater Construction Program (70492), CIP No. 46-148.0 for the purposes set forth therein and in agreements executed by the City Manager for the accomplishment of said project.

Section 4. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
