ORDINANCE NUMBER O- 16876 (NEW SERIES)

ADOPTED ON JUN 08 1987

AN ORDINANCE INCORPORATING PARCEL 1 OF PARCEL MAP 3253 FILED IN THE OFFICE OF THE COUNTY RECORDER OF SAN DIEGO COUNTY NOVEMBER 22, 1984 AS FILE NO. 74-308807, LOCATED ON THE NORTH SIDE OF KEARNY MESA ROAD, BETWEEN MERCURY STREET AND MAGNATRON BOULEVARD, IN THE SERRA MESA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO M-1 ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0437, AND REPEALING ORDINANCE NO. 6714 (NEW SERIES), ADOPTED OCTOBER 13, 1955, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that within three years of the effective date of this ordinance incorporating Parcel 1 of Parcel Map 3253 filed in the office of the County Recorder of San Diego County November 22, 1984 as File No. 74-308807, located on the north side of Kearny Mesa Road, between Mercury Street and Magnatron Boulevard, in the Serra Mesa Community Plan area, in the City of San Diego, California, designated "M-1" on Zone Map Drawing No. B-3764, is subdivided and a map or maps thereof duly submitted to the City and thereafter recorded, and within such subdivision or subdivisions provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of San Diego Municipal Code Section 101.0437 shall attach and become applicable to the said subdivided land, and the said subdivided


land shall be incorporated into M-1 Zone, as described and defined by Section 101.0437, the boundary of such zone to be as indicated on Zone Map Drawing No. B-3764, filed in the office of the City Clerk as Document No. 769543. Said zoning shall attach only to those areas included in the map as provided in this section.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1 of this ordinance, Ordinance No. 6714 (New Series), adopted October 13, 1955, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
