ORDINANCE NUMBER O- 16894 (NEW SERIES)

ADOPTED ON JUL 13 1987

AN ORDINANCE PREZONING PORTIONS OF SECTIONS 26, 27 AND 35, TOWNSHIP 14 SOUTH, RANGE 2 WEST (APPROXIMATELY 386 ACRES), LOCATED WEST OF POMERADO ROAD, BETWEEN POWAY ROAD AND POMERADO ROAD, IN THE COUNTY OF SAN DIEGO, CALIFORNIA, INTO A-1-10 AND HR ZONES AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTIONS 101.0404 AND 101.0454.


BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That portions of Sections 26, 27 and 35, Township 14 South, Range 2 West (approximately 386 acres), located west of Pomerado Road, between Poway Road and Pomerado Road, in the County of San Diego, California, within the boundaries of the district designated "A-1-10" and "HR" on that certain Zone Map Drawing No. C-709.2, filed in the office of the City Clerk under Document No. 00-16894, be, upon annexation to The City of San Diego, incorporated into A-1-10 and HR Zones as defined by San Diego Municipal Code Sections 101.0404 and 101.0454.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, or the effective date of the annexation, whichever is later.
