ORDINANCE NUMBER O- 16905 (NEW SERIES)

ADOPTED ON NOV 26 1987

AN ORDINANCE INCORPORATING LOT 1 OF MISSION VALLEY GARDENS, MAP NO. 5231, LOCATED ON THE SOUTH SIDE OF CAMINO DEL RIO SOUTH, BETWEEN MILLY WAY AND INTERSTATE 15, IN THE MISSION VALLEY COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CO ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0423, AND REPEALING ORDINANCE NO. 11116 (NEW SERIES), ADOPTED SEPTEMBER 6, 1973, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, IN SO FAR AS THE SAME CONFLICT(S) HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lot 1 of Mission Valley Gardens, Map No. 5231, located in the Mission Valley Community Plan area, in the City of San Diego, California, within the boundary of the district designated "CO" on Zone Map Drawing No. B-3828, filed in the office of the City Clerk as Document No. 769589, be, and it is hereby incorporated into CO Zone, as such zone is described and defined by San Diego Municipal Code Section 101.0423.

Section 2. That Ordinance No. 11116 (New Series), adopted September 6, 1973, of the ordinances of The City of San Diego be and it is repealed insofar as the same conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
