

ORDINANCE NUMBER O-16907 (NEW SERIES)

ADOPTED ON JUL 20 1987

AN ORDINANCE INCORPORATING THOSE PROPERTIES BOUNDED APPROXIMATELY BY INTERSTATE 5 ON THE WEST, INTERSTATE 8 ON THE NORTH, THE MISSION HILLS NEIGHBORHOOD OF THE UPTOWN COMMUNITY PLANNING AREA ON THE EAST, AND WITHERBY STREET ON THE SOUTH, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO THE OLD SAN DIEGO PLANNED DISTRICT AND OTHER ZONES, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 103.0200, ET AL., AND REPEALING THOSE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:


Section 1. That those properties bounded approximately by Interstate 5 on the west, Interstate 8 on the north, the Mission Hills neighborhood of the Uptown Community Planning Area on the east, and Witherby Street on the south, in the City of San Diego, California, within the boundary designated on Zone Map No. C-289.5, filed in the office of the City Clerk as Document No.

00-16906, be, and it is hereby incorporated into the Old San Diego Planned District and other zones, as such zones are described and defined by San Diego Municipal Code Section 103.0200, et al.

Section 2. That all prior ordinances of the ordinances of The City of San Diego be and they are repealed insofar as the same conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the introduction of this ordinance or a hearing before the Old San Diego Planned District Review Board was held prior to the effective date of this ordinance.
