AN ORDINANCE INCORPORATING THOSE AREAS IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO SINGLE-FAMILY RENTAL OVERLAY ZONE AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0461.
