AN ORDINANCE INCORPORATING THOSE AREAS IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO SINGLE-FAMILY RENTAL OVERLAY ZONE AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0461.


BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Those areas in the City of San Diego, California, within the boundary of the district designated "Single-family Rental Overlay Zone" on Zone Map Drawing No. C-733, filed in the office of the City Clerk as Document No. OO-16868, be, and they are hereby incorporated into the Single-Family Rental Overlay Zone, as such zone is described and defined by San Diego Municipal Code Section 101.0461.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
