AN ORDINANCE CALLING A GENERAL MUNICIPAL ELECTION IN THE CITY OF SAN DIEGO ON TUESDAY, NOVEMBER 3, 1987.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. It is hereby ordered that a General Municipal Election will be held in the City of San Diego on Tuesday, November 3, 1987, for the purpose of electing candidates for the following offices:

COUNCILMEMBER for District No. 2 four-year term

COUNCILMEMBER for District No. 4 four-year term

COUNCILMEMBER for District No. 6 four-year term

COUNCILMEMBER for District No. 8 four-year term

Section 2. For the purpose of said election, the election precincts shall be the precincts established by the Board of Supervisors of the County of San Diego; provided, however, that certain of said precincts shall be consolidated in the manner indicated on the list on consolidated precincts on file in the office of the City Clerk.

Section 3. The City Clerk shall designate the polling places, and shall appoint the members of the precinct boards for said election.

Section 4. That the polls for said election shall be open from 7 a.m. until 8 p.m. on Tuesday, November 3, 1987.

Section 5. The City Clerk is hereby directed to procure and supply the required number of ballots, sample ballots, equipment, supplies and other printed matter.

Section 6. The following rates of compensation are hereby established for said election:

Clerks	\$35.00
Rental of Polling Place	\$25.00
