WHEREAS, this Council has commenced proceedings and intends to call a Special Municipal Bond Election in the City to be held on November 3, 1987 for the purpose of submitting to the qualified voters of the City general obligation bond propositions as set forth in this ordinance; and

WHEREAS, at a meeting held on July 20, 1987, being a meeting held prior to the meeting at which this ordinance is adopted, the City Council of The City of San Diego, by a vote of at least two-thirds of all its members, adopted Resolution No. R-268896 determining that the public interest and necessity demand the acquisition and construction of park and recreation municipal improvements in the City, including but not necessarily limited to, restoration, renovation and improvements to Balboa Park and Mission Bay Park, including the reconstruction and renovation of buildings and arcades in Balboa Park, and the restoration of water quality and beaches in Mission Bay Park, development of

South Shores Park, public restroom improvements, the construction of pedestrian and bicycle pathways, improvements to parking lots, Crown Point and other park areas, all in Mission Bay Park, and improved senior citizen, handicapped, pedestrian-vehicle circulation and access, construction of a new garden in Gold Gulch, Space Theater and Starlight Bowl improvements, all in Balboa Park, and a new gym outside Balboa Park; and

WHEREAS, it is desirable that this Special Municipal Bond Election be consolidated with the General Municipal Election to be held on the same date and that within the City, the election precincts, polling places, voting booths and election officials for the two elections be the same, and that the City Clerk of the City of San Diego be authorized to canvass the returns of the Special Municipal Bond Election, and that this Special Municipal Bond Election and the General Municipal Election be held in all respects as if there were only one election; and

WHEREAS, after the adoption of this ordinance, the Council of The City of San Diego will by resolution make a timely request to the Board of Supervisors of the County of San Diego to order the consolidation of the Special Municipal Bond Election to be held on November 3, 1987, with the General Municipal Election to be held on the same date; and

WHEREAS, the Board of Supervisors of the County of San Diego is expected to grant the request and order the consolidation of the two elections; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, California, as follows:

Section 1. A Special Municipal Bond Election is hereby called and ordered to be held in the City of San Diego,

Section 14. The City Clerk shall cause this ordinance to be published once a week for two weeks in the official newspaper no

later than fifty days before the date of the election. No other notice of the election need be given.

Section 15. Pursuant to Section 17 of the Charter, this ordinance relating to elections shall take effect on JUL 27 1987, being the day of its introduction and passage.

## PROPOSITION . BALBOA PARK AND MISSION BAY PARK PRESERVATION AND IMPROVEMENT
