AN ORDINANCE AMENDING ORDINANCE NO. 0-16916 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENTS NO. 00-16916-1 AND NO. 00-16916-2. AS AMENDED AND ADOPTED THEREIN, BY ADDING TO THE PERSONNEL AUTHORIZATION OF THE PLANNING DEPARTMENT (065), TWO (2) ASSOCIATE PLANNER POSITIONS, ONE AND ONE-HALF (1.5) ZONING REPRESENTATIVE POSITIONS, ONE (1) CLERICAL ASSISTANT II, AND ONE-QUARTER (0.25) GRAPHICS DESIGNER; AUTHORIZING THE AUDITOR AND COMPTROLLER TO TRANSFER THE SUM OF \$37,953 WITHIN THE GENERAL FUND 100 FROM THE UNALLOCATED RESERVE (605) TO THE PLANNING DEPARTMENT (065); AND AUTHORIZING THE AUDITOR AND COMPTROLLER TO INCREASE THE PLANNING DEPARTMENT APPROPRIATION (065) BY \$150,000, TO BE RECOVERED BY NEW ADDITIONAL REVENUE FROM PERMIT FEE ACTIVITY, FOR THE PURPOSE OF FULLY FUNDING THE ABOVE AUTHORIZED POSITIONS AND RELATED NONPERSONNEL EXPENDITURES FOR FISCAL YEAR 1988.

WHEREAS, on June 4, 1987, the Planning Commission approved the Southeast San Diego Ordinance; and

WHEREAS, said Commission consideration encompassed review and discussion of Planning Department Report No. 87-262 which recommended appropriate staff as a result of the new Southeast San Diego District; and

WHEREAS, said positions are to be hired during fiscal year 1988, to be funded from the Unallocated Reserve and new revenue from permit fee activities, and, in succeeding years, to be regularly budgeted; and

WHEREAS, it is now necessary to amend the annual appropriation ordinance to effectuate such addition to the Planning Department budget; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16916 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Documents No. OO-16916-1 and No. OO-16916-2, as amended and adopted therein, by adding to the personnel authorization schedule of the Planning Department (065), two (2) Associate Planner positions, one and one-half (1.5) Zoning Representative positions, one (1) Clerical Assistant II position, and one-quarter (0.25) Graphics Designer position.

Section 2. That the Auditor and Comptroller be and he is hereby authorized and directed to transfer within the General Fund 100, the sum of \$37,953 from the Unallocated Reserve (605) to the Planning Department (065) and increase the budget appropriation for the Planning Department by \$150,000, to be recoverable from new permit fee revenue, for the purpose of fully funding the above newly-authorized positions for the remainder of fiscal year 1988.

Section 3. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings,

pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
