AN ORDINANCE INCORPORATING ALL THAT AREA IN THE SOUTHEAST SAN DIEGO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO THE SOUTHEAST SAN DIEGO PLANNED DISTRICT, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 103.1700, ET SEQ., AND REPEALING THOSE ORDINANCES OF THE CITY OF SAN DIEGO THAT CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That all that area in the Southeast San Diego Community Plan area, in the City of San Diego, California, within the boundary of the district designated "Southeast San Diego Community Planned District" on Zone Map Drawing Nos. C-732-A through C-732-Q, filed in the office of the City Clerk as Document No. 16922, be, and it is hereby incorporated into Southeast San Diego Community Planned District, as such district is described and defined by San Diego Municipal Code Section 103.1700, et seq.

Section 2. That all those of the ordinances of The City of San Diego that conflict herewith, be and they are repealed insofar as the same conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
