AN ORDINANCE AMENDING ORDINANCE NO. O-16916 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-16916-1 AS AMENDED AND ADOPTED THEREIN, BY AMENDING THE PERSONNEL AUTHORIZATION OF NON-DEPARTMENTAL EXPENDITURES (60154) AND THE EXECUTIVE SERVICES DEPARTMENT (01100), BOTH IN GENERAL FUND 100, BY EXEMPTING RESPECTIVELY ONE (1.00) COUNCIL REPRESENTATIVE I AND COUNCIL REPRESENTATIVE II POSITIONS IN DEPARTMENT 60154 AND ONE (1.00) COUNCIL REPRESENTATIVE II POSITION IN DEPARTMENT 01100 FROM THE CLASSIFIED SERVICE; AND ESTABLISHING A SALARY RATE THEREFOR.

WHEREAS, the Mayor's Department has requested the exemption from the Classified Service of one (1.00) Council Representative I and one (1.00) Council Representative II positions in Citizens Committee Administration (60154) and one (1.00) Council Representative II position in Executive Services (01100), which positions are already authorized; and

WHEREAS, section 117(a)(17) of the Charter provides that "managerial employees having significant responsibilities for formulating or administering departmental policies and programs" may be exempted from the Classified Service by ordinance upon first having been reviewed and commented upon by the Civil Service Commission; and

WHEREAS, the Civil Service Commission reviewed this requested on July 23, 1987 and commented favorably in the July 29, 1987

letter from the Personnel Director upon the exemptions as meeting the criteria set forth in the Charter; and

WHEREAS, it is necessary to amend the annual appropriation ordinance to effectuate said exemption from the Classified Service; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16916 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-16916-1, as amended and adopted therein, by:

(a) amending the personnel authorization schedule of Department 601, Non-Departmental Expenditures, General Fund 100 [Citizens Committee Administration-60154], to reflect the exemption of one (1.00) Council Representative I position and one (1.00) Council Representative II position from the Classified Service and direct their inclusion in the Unclassified Service of The City of San Diego, as provided in Exhibit C, Managerial Categories A and B;


(b) amending the personnel authorization of Department 01100, Executive Services Department, General Fund 100, to reflect the exemption of one (1.00) Council Representative II position from the Classified Service and direct its inclusion in the Unclassified Service of The City of San Diego, placing said position in Managerial Category B of Exhibit C.

Section 2. That pursuant to section 117(a)17 of the City Charter, after having been reviewed by the Civil Service Commission on July 23, 1987, the Commission has commented favorably upon the request for exemption of said positions from the Classified Service.

Section 3. As a schedule of compensation for the above three (3.00) unclassified positions, the salary rates for Council Representative I and Council Representative II, set forth in Salary Rates 07.0, 07.1 and 07.2, and 07.3, 07.4 and 07.5 of the Table of Classifications and Standard Salary Rates under Managerial Category A and B respectively, contained in Exhibit C to Ordinance No. O-16867 (New Series), dated May 26, 1987, be and the same are hereby adopted.

Section 4. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
