AN ORDINANCE AMENDING ORDINANCE NO. 0-16916, (NEW SERIES) AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY INCREASING THE GENERAL FUND 100 APPROPRIATION BY THE AMOUNT OF \$3,950,000, SAID AMOUNT REPRESENTING FISCAL YEAR 87 UNAPPROPRIATED GENERAL FUND 100 CLOSING UNDESIGNATED FUND BALANCE; DIRECTING THAT THE ABOVE SUM OF \$3,950,000 BE APPROPRIATED INTO THE UNALLOCATED RESERVE (605); AUTHORIZING THE AUDITOR AND COMPTROLLER TO TRANSFER THE SUM OF \$3,915,000 FROM THE GENERAL FUND 100, UNALLOCATED RESERVE (605) TO THE WETLANDS ACQUISITION FUND (10545), TO BE EXPENDED ONLY BY RESOLUTION OF THE CITY COUNCIL; FURTHER AMENDING THE PERSONNEL AUTHORIZATION OF THE PLANNING DEPARTMENT (065) BY ADDING ONE (1.00) ZONING INVESTIGATOR I POSITION; AND AUTHORIZING THE AUDITOR AND COMPTROLLER TO TRANSFER THE SUM OF \$35,000 WITHIN THE GENERAL FUND 100 FROM THE UNALLOCATED RESERVE (605) TO THE PLANNING DEPARTMENT (065) APPROPRIATION TO DEFRAY COSTS OF THE NEWLY AUTHORIZED POSITION.

WHEREAS, during review of the Proposed Fiscal Year 1988

Budget it became necessary to provide for the transfer of the fund balance at June 30, 1987 in the Wetlands Acquisition Fund to the General Fund in order to finance several important programs; and

WHEREAS, at that time the Manager advised that should the ending Fiscal Year 1987 General Fund 100 undesignated fund balance be higher than the estimates used at the time, a recommendation would be made to restore monies to the Wetlands Acquisition Fund to the extent possible; and

WHEREAS, it now appears, that subject to the final outside audit, the ending Fiscal Year 1987 General Fund 100 undesignated balance will contain a surplus of \$3,950,000, which can now be made available to partially restore funds transferred from the Wetlands Acquisition Fund; and

WHEREAS, the report of the City Manager for this matter sets forth the information discussing said additional funds with a recommendation to effectuate such transfer; and

WHEREAS, it has been requested that a new position be added to the Planning Department (065), said position to be a Zoning Investigator I, for the purpose of providing staff support in the area of single family rental overlay zone; and

WHEREAS, the costs involved in said additional position is an annual amount of \$35,000, consisting of \$32,009 in personal services and \$2,991 in other non-personal services; and

WHEREAS, it is necessary for Council to amend the annual appropriation ordinance to provide the authorization of the new position and for the transfer of the specified funds; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16916 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-16916-1, by increasing the General Fund 100 appropriation for the Unallocated

Reserve (605) by the sum of \$3,950,000, said sum representing heretofore unappropriated Fiscal Year 1987, General Fund 100, closing undesignated fund balance.

Section 2. That the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$3,915,000 from the General Fund 100, Unallocated Reserve (605) to the Wetlands Acquisition Fund (10545), to thereafter be expended only by resolution of the City Council.

Section 3. That the personnel authorization of the Planning Department (065) be and it is hereby amended by adding thereto one (1.00) Zoning Investigator I position to provide staff support in the area of single family rental overlay zone.

Section 4. That the Auditor and Comptroller be and he is hereby authorized to transfer within the General Fund 100 the sum of \$35,000 from the Unallocated Reserve (605) to the Planning Department (065) for the sole and exclusive purpose of funding the new position added to the department in Section 3. above for the fiscal year 1988.

Section 5. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.

The increased appropriation is to be placed in the Unallocated Reserve (605). The ordinance further/directs the Auditor and Comptroller to transfer from the Unallocated Reserve (605) to the Wetlands Acquisition Fund (10545) the sum of \$3,915,000, which shall be expended only be resolution of the Council.
