ORDINANCE NUMBER O-_____ (NEW SERIES)

ADOPTED ON SEP 28 1987

AN ORDINANCE AMENDING CHAPTER V, ARTICLE 9, DIVISION 1, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTIONS 59.0102 AND 59.0104 RELATING TO THE SAN DIEGO JACK MURPHY STADIUM PARKING FACILITY.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter V, Article 9, Division 1, of the San Diego Municipal Code be and the same is hereby amended by amending Sections 59.0102 and 59.0104 to read as follows:

SEC. 59.0102 DEFINITIONS

Whenever in this Division the words or phrases in this section defined are used, they shall have the respective meanings assigned to them as follows:

(a) through (k) - No change.

(l) "Overflow Capacity Event" shall mean any event in the San Diego Jack Murphy Stadium in which attendance is anticipated to be in excess of sixty-five thousand (65,000) people.

SEC. 59.0104 ACTIVITIES PROHIBITED WITHIN THE SAN DIEGO JACK MURPHY STADIUM PARKING FACILITY

(a) through (d) - No change.


(e) No person shall bring or attempt to bring a vehicle into San Diego Jack Murphy Stadium Parking Facility without paying the prescribed charge required for admission. On the

day of, during and for eight (8) hours after any event duly designated by the City Manager as an "Overflow Capacity Event," no person shall enter or attempt to enter San Diego Jack Murphy Stadium Parking Facility without presenting a valid ticket or pass to that event, or a pass indicating that the person is an on-duty employee working the event; provided, however, that notices of such prohibition shall be duly posted at least twenty-four (24) hours prior to the event and remain posted throughout the event and the eight (8) hour period thereafter.

(f) through (k) - No change.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.


