AN ORDINANCE INCORPORATING LOTS 88 AND 89, LUSK INDUSTRIAL PARK UNIT NO. 3, MAP NO. 10361, LOCATED WEST OF SCRANTON ROAD, BETWEEN BARNES CANYON ROAD AND MOREHOUSE DRIVE, IN THE MIRA MESA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CR ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0421.1, AND REPEALING ORDINANCE NO. 15315 (NEW SERIES), ADOPTED MARCH 31, 1982, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT(S) HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lots 88 and 89, Lusk Industrial Park Unit No. 3, Map No. 10361, located west of Scranton Road, between Barnes Canyon Road and Morehouse Drive, in the Mira Mesa Community Plan area, in the City of San Diego, California, within the boundary of the district designated "CR" on Zone Map Drawing No. B-3820, filed in the office of the City Clerk as Document No. 769620, be, and it is hereby incorporated into CR Zone, as such zone is described and defined by San Diego Municipal Code Section 101.0421.1.

Section 2. That Ordinance No. 15315 (New Series), adopted August 25, 1982, of the ordinances of The City of San Diego be and it is repealed insofar as the same conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
