AN ORDINANCE INCORPORATING THE NORTHERN HALF OF THE WESTERN HALF OF THE NORTHEAST QUARTER AND A PORTION OF THE EASTERLY HALF OF THE NORTHEAST QUARTER OF PUEBLO LOT 1307, LOCATED WEST OF I-805, BETWEEN EASTGATE MALL AND LA JOLLA VILLAGE DRIVE, IN THE UNIVERSITY COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO SR ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0434, AND REPEALING ORDINANCE NO. 10936 (NEW SERIES), ADOPTED OCTOBER 5, 1972, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT(S) HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that within three years of the effective date of this ordinance incorporating the northern half of the western half of the northeast quarter and a portion of the easterly half of the northeast quarter of the northeast quarter of Pueblo Lot 1307, located west of I-805, between Eastgate Mall and La Jolla Village Drive, in the University Community Plan area, in the City of San Diego, California, designated "SR" on Zone Map Drawing No. B-3815, is subdivided and a map or maps thereof duly submitted to the City and thereafter recorded, and within such subdivision or subdivisions provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of San Diego Municipal Code Section 101.0434 shall attach and become

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1 of this ordinance, Ordinance No. 10936 (New Series), adopted October 5, 1972, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
