ORDINANCE NUMBER O- 16958 (NEW SERIES)

ADOPTED ON OCT 12 1987

AN ORDINANCE INCORPORATING LOT 4, PARCEL NOS. 32, 34 AND 40 OF PUEBLO LOT 1215, MAP NO. 690, LOCATED ON LINDA VISTA ROAD, IN THE LINDA VISTA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CO ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0423, AND REPEALING ORDINANCE NO. 13457, APPROVED FEBRUARY 23, 1932, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT(S) HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lot 4, Parcel Nos. 32, 34 and 40 of Pueblo Lot 1215, Map No. 690, located on Linda Vista Road, in the Linda Vista Community Plan area, in the City of San Diego, California, within the boundary of the district designated "CO" on Zone Map Drawing No. B-3835, filed in the office of the City Clerk as Document No. 769608, be, and it is hereby incorporated into CO Zone, as such zone is described and defined by San Diego Municipal Code Section 101.0423.

Section 2. That Ordinance No. 13457, approved February 23, 1932, of the ordinances of The City of San Diego be and it is repealed insofar as the same conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
