ORDINANCE NUMBER O- 16959 (NEW SERIES)

ADOPTED ON OCT 12 1987

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 16563 (NEW SERIES), ADOPTED DECEMBER 16, 1985, INCORPORATING PARCEL MAP NO. 9470, AND PORTIONS OF PUEBLO LOTS 1303 AND 1278 (LOTS 1-20, TM-85-0533), LOCATED ON THE EAST SIDE OF TOWNE CENTRE DRIVE BETWEEN LA JOLLA VILLAGE DRIVE AND NOBEL DRIVE, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1500 AND CN ZONES, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTIONS 101.0410 AND 101.0426, RESPECTIVELY.

WHEREAS, a request has been received to extend the time on Ordinance No. O-16563 (New Series), adopted December 16, 1985, which provided that the R-1500 and CN Zones would attach if a final subdivision map(s) was recorded on or before January 6, 1988; and

WHEREAS, the requested extension of time will permit the successful conclusion and implementation of the zoning pattern heretofore approved by the Planning Commission; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:


Section 1. That Section 1. of Ordinance No. 16563 (New Series), adopted December 16, 1985, is hereby amended to read as follows:

Section 1. That in the event that Parcel Map 9470 and portions of Pueblo Lots 1303 and 1278 (Lots 1-20, TM-85-0533), located on the east side of Towne Centre Drive between La Jolla Village Drive and Nobel Drive, in the City of San Diego, California, within the boundary of the district designated "R-1500" and "CN" on that certain Zone Map Drawing No. B-3479.3, is subdivided and a final subdivision map or maps thereof duly submitted to the City on or before January 6, 1991, and thereafter recorded, and within such subdivision or subdivisions provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of San Diego Municipal Code Sections 101.0410 and 101.0426 shall attach and become applicable to said subdivided land and said subdivided land shall be incorporated into R-1500 and CN Zones, as described by Sections 101.0410 and 101.0426, the boundary of such zones to be as indicated on Zone Map Drawing No. B-3479.3, filed in the office of the City Clerk as Document No. 769604. Said zoning shall attach only to those areas included in the subdivision map or maps recorded as provided in this section.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
