ADOPTED ON OCT 13 1987

AN ORDINANCE AMENDING ORDINANCE NO. O-16916 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-16916-1, AS AMENDED AND ADOPTED THEREIN, BY EXEMPTING FROM THE CLASSIFIED SERVICE ONE (1.00) PRINCIPAL PLANNER POSITION IN THE PLANNING DEPARTMENT (065); AND ESTABLISHING A SALARY RATE THEREFOR.

WHEREAS, on July 28, 1987, the City Council authorized, via Ordinance No. O-16916 (New Series), the addition of one (1.00) Principal Planner position to the Planning Department (065) for the purpose of assuming primary responsibility for the Coastal Permit Program (06533); and

WHEREAS, it has been requested that the newly authorized Principal Planner position be exempted from the Classified Service and placed in the Unclassified Service; and

WHEREAS, section 117(a)17 of the Charter provides that "managerial employees having significant responsibilities for formulating or administering departmental policies and programs" shall be exempted from the Classified Service by ordinance upon first having been reviewed and commented upon by the Civil Service Commission; and

WHEREAS, the Civil Service Commission reviewed this request on September 3, 1987 and has commented unfavorably upon the exemption as meeting the criteria set forth in the Charter; and

WHEREAS, it is nevertheless requested that the annual appropriation ordinance be amended to effectuate said exemption from the Classified Service; NOW, THEREFORE

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That after receiving the September 3, 1987 review and the unfavorable comment thereon by the Civil Service Commission pursuant to Charter section 117(a)(17), this Council nonetheless directs that Ordinance No. O-16916 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-16916-1, as adopted and amended therein, by exempting from the Classified Service one (1.00) Principal Planner position in the Planning Department (065), Program 06533, and declaring the same to be in the Unclassified Service of The City of San Diego.

Section 2. As a schedule of compensation for the above unclassified position declared in Section 1. above, the salary rate set forth in Salary Rates 7.7, 7.8 and 7.9 of the Table of Classifications and Standard Salary Rates under Managerial Category C, contained in Exhibit C to Ordinance No. O-16867 (New Series), dated May 26, 1987 be and the same is hereby adopted.

Section 3. This ordinance shall take effect and be in force immediately upon its passage after two (2) public hearings

pursuant to the authority contained in sections 16, 17 and 71 of
the Charter of The City of San Diego.
