That Ordinance No. O-16916 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Documents No. OO-16916-1 and No. OO-16916-2, as amended and adopted therein, by adding to the personnel authorization schedule of the Planning Department (065) Program Element 06532, 0.64 Associate Planner position.

Section 2. That the Auditor and Comptroller be and he is hereby authorized and directed to transfer within the General Fund 100, the sum of \$29,491 from the Unallocated Reserve (605)

to the Planning Department (065) and increase the budget appropriation for the Planning Department by said amount, for the purpose of fully funding the above newly-authorized position for the remainder of fiscal year 1988, allocating \$26,611 to Personnel Services and \$2,880 to Non-Personnel expenses.

Section 3. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
