AN ORDINANCE AMENDING ORDINANCE NO. 0-16867 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1987-88" BY AMENDING EXHIBIT B THERETO TO CREATE AND ADD A NEW CLASS ENTITLED "HORTICULTURIST" IN THE PARK MAINTENANCE OCCUPATIONAL GROUP; AMENDING EXHIBIT A-1 OF SAID ORDINANCE TO PROVIDE A NEW SALARY RATE NUMBER 51.4 FOR SAID POSITION IN THE CLASSIFIED SERVICE, AS SET FORTH IN ATTACHMENT A HERETO; AMENDING RESOLUTION NO. R-268320 TO PLACE THE NEWLY CREATED CLASS IN THE SUPERVISORY REPRESENTATION UNIT; AND AMENDING RESOLUTION NO. R-268319 TO APPROVE AND DECLARE THE ABOVE NEWLY CREATED CLASS AS ELIGIBLE FOR REGULAR RATE OVERTIME BY PLACING IT IN GROUP C OF SAID OVERTIME ELIGIBILITY RESOLUTION NO. R-268319.

WHEREAS, the Park and Recreation Department has requested the establishment of a new classification to plan and manage a street and park tree maintenance and replacement program for the City; and

WHEREAS, as proposed, this position would plan, coordinate, and manage the City-wide urban forestry program; serve as the department's tree expert; supervise the work of subordinates engaged in street tree maintenance and park tree maintenance; perform long range planning for the planting and/or replacement of trees in City parks, center islands, and street right-of-ways; evaluate ordinances and codes that pertain to the City trees to determine if revisions are needed; develop contract specifications and administer contracts for tree trimming,

removal, and pest control; evaluate current department tree maintenance policies and procedures and revise as necessary; prepare responses to route slips and inquiries from the public; and perform other related duties; and

WHEREAS, this is a highly specialized and professional level duty and requires a minimum of a college degree in park management combined with two years of professional level park management experience to provide the necessary managerial skills and technical expertise necessary for these positions; and

WHEREAS, no current City classification meets these requirements and it is therefore recommended that a new classification of Horticulturist be created which may be used to fill any of the above positions with specialized targeted recruiting; and

WHEREAS, it is further recommended that the salary level of this class be established at \$2,278 to \$2,750 per month; and

WHEREAS, it is also recommended that this class be eligible for regular rate overtime under the same conditions as other professional City classes which are included in Group C of the Addendum to Personnel Manual Section H-4, Overtime; and

WHEREAS, included in the group are those classes designated as exempt from the overtime provisions of the Fair Labor Standards Act but eligible for regular rate overtime in accordance with City policy; and

WHEREAS, at its regularly scheduled meeting of September 3, 1987, the Civil Service Commission considered fully the matter of this new position, approved all aspects of the classification as

recited above, and now forwards the matter to the City Council for appropriate legislative action; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16867 (New Series), entitled "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1987-88" be and the same is hereby amended by amending Exhibit B thereto by creating and adding a new class, entitled "HORTICULTURIST" in the Park Maintenance Occupation Group at salary rate number 51.4.

Section 2. That Exhibit A-1 of the above-cited ordinance be amended to include a new salary rate number 51.4, ranging from \$2,278 to \$2,750 per month, at rates and steps as set forth in Attachment A hereto.

Section 3. That Resolution No. R-268320, adopted May 11, 1987 be and it is hereby amended to place the newly created class of Horticulturist in the Supervisory Representation Unit.

Section 4. That Resolution No. R-268319, adopted May 11, 1987, be and it is hereby amended by approving and declaring the newly created class as eligible for regular rate overtime and placing said newly created class in Group C Overtime Eligibility.

Section 5. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
