AN ORDINANCE INCORPORATING THOSE COMMERCIAL ZONED AREAS IN THE NEWPORT CENTER COMMERCIAL DISTRICT, BOUNDED BY SUNSET CLIFFS BOULEVARD, NIAGARA AVENUE, ABBOTT STREET AND SANTA MONICA AVENUE, IN THE OCEAN BEACH PRECISE PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO THE PEDESTRIAN/COMMERCIAL OVERLAY ZONE AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0458.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That those commercial zoned areas in Newport
Center Commercial District, bounded by Sunset Cliffs Boulevard,
Niagara Avenue, Abbott Street and Santa Monica Avenue, in the
Ocean Beach Precise Plan area, in the City of San Diego,
California, within the boundary of the district designated
"Pedestrian/Commercial Overlay Zone" on Zone Map Drawing No.
C-747, filed in the office of the City Clerk as Document
No. __769627, be, and it is hereby incorporated into the
Pedestrian/Commercial Overlay Zone, as such zone is described and
defined by San Diego Municipal Code Section 101.0458.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
