AN ORDINANCE AMENDING ORDINANCE NO. 0-16916 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY ACCEPTING \$12 MILLION FROM THE REDEVELOPMENT AGENCY AND DIRECTING THE AUDITOR AND COMPTROLLER TO APPROPRIATE AND ALLOCATE SAID FUNDS TO NEWLY CREATED CIP PROJECTS 39-300, 39-305 AND 39-310; CREATING CIP PROJECTS 39-300, ENTITLED "MARINA REDEVELOPMENT-PUBLIC IMPROVEMENTS (CDBG), " 39-305, ENTITLED "COLUMBIA REDEVELOPMENT PROJECT-PUBLIC IMPROVEMENTS (CDBG), " AND 39-310, ENTITLED "COLUMBIA REDEVELOPMENT PROJECT-LOW AND MODERATE INCOME HOUSING FUND (CDBG)" AND AUTHORIZING THE AUDITOR AND COMPTROLLER TO APPROPRIATE AND ALLOCATE TO THE ABOVE NEWLY CREATED CIP PROJECTS THE SUMS OF \$10.4 MILLION, \$0.6 MILLION, AND \$1.0 MILLION, RESPECTIVELY; DIRECTING THE AUDITOR AND COMPTROLLER TO DISBURSE THE ABOVE RECITED CDBG FUNDS TO THE REDEVELOPMENT AGENCY FROM THE CIP PROJECTS FOR THE PURPOSES RECITED THEREIN; ACCEPTING \$6.0 MILLION FROM THE REDEVELOPMENT AGENCY TO INCREASE THE CONTRIBUTIONS TO THE REDEVELOPMENT AGENCY (10227) BY UP TO SAID AMOUNT AND DIRECTING THE AUDITOR AND COMPTROLLER TO APPROPRIATE AND ALLOCATE SAID FUNDS TO NEWLY CREATED CIP PROJECT 39-315; CREATING CIP PROJECT 39-315, ENTITLED "MARINA REDEVELOPMENT PROJECT-PUBLIC IMPROVEMENTS; DIRECTING THE AUDITOR AND COMPTROLLER TO DISBURSE THE FUNDS UP TO \$6.0 MILLION TO THE REDEVELOPMENT AGENCY FROM CIP 39-315: RECORDING ABOVE-RECITED DISBURSEMENTS TO THE REDEVELOPMENT AGENCY AS INTEREST BEARING LOANS TO BE REPAID AS SOON AS PRACTICABLE FROM TAX INCREMENT OR OTHER REVENUES; AND PROVIDING FOR PRIORITY OF CLAIM UPON REVENUES OF THE REDEVELOPMENT AGENCY.

WHEREAS, the Council of The City of San Diego (the "City")
has previously given its general approval to financing plans for
the Columbia Redevelopment Project and the Marina Redevelopment
Project of the Redevelopment Agency of The City of San Diego (the
"Agency"); and

WHEREAS, said financing plans included the issuance of tax allocation debt to finance public facilities within each of the above-named project areas; and

WHEREAS, the Agency has adopted budgets for those projects for Fiscal Year 1987-88; and

WHEREAS, the City has adopted the Fiscal Year 1987-88 Capital Improvement Budget; and

WHEREAS, such Agency budgets and City Capital Improvement
Budget identify funds to be utilized in the redevelopment project
areas; and

WHEREAS, it has been recommended that the City Council amend the annual budget to accept certain payments from the Agency, establish specified Capital Improvement Projects to accommodate the funding for the Agency for said projects, and authorize the City Auditor and Comptroller to pay over said specified funds to the Agency; and

WHEREAS, the new CIP Projects and purposes stated therein are:

1. CIP PROJECT NO. 39-300, entitled "Marina Redevelopment - Public Improvements (CDBG)" for the purpose of land acquisition, relocation, demolition, public improvements and other related administrative costs

associated with the land assembly for a linear park and residential development;

- 2. CIP PROJECT NO. 39-305, entitled "Columbia Redevelopment Project Public Improvements (CDBG)" for the purpose of engineering and public improvements and related administrative costs associated with the implementation of such public improvements;
- 3. CIP PROJECT NO. 39-310, entitled "Columbia Redevelopment Project Low and Moderate Income Housing Fund (CDBG)" for the purpose of development of low and moderate income housing providing that the aggregate of monies described in section 2 of this ordinance shall equal the amount received by the City under section 1 below;
- 4. CIP PROJECT NO. 39-320, entitled "Marina Redevelopment Project Public Improvement" for the purpose of public improvements including parks, streets, soils, and other related public improvements and administrative costs within the Marina Redevelopment Project provided that the amount described in section 5 of this ordinance shall equal the amount received by the City under section 4 below;

and

WHEREAS, it is now necessary and recommended that the City Council take required actions as recited herein; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16916 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR

THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" be and the same is hereby amended by amending Document No. 00-16916-1, as amended, by accepting up to \$12 million from the Redevelopment Agency to CDBG Program Income Fund 18502 representing payment of principal and interest on Community Development Block Grant loans made to the Agency in the Columbia Redevelopment Project and directing the Auditor and Comptroller to appropriate and allocate said funds to newly created CIP Projects No. 39-300, 39-305 and 39-310, as indicated below.

Section 2. That pursuant to section IV of the annual appropriation ordinance, the Auditor and Comptroller is hereby authorized and directed to establish new CIP Projects No. 39-300, entitled "Marina Redevelopment - Public Improvements (CDBG)," 39-305, entitled "Columbia Redevelopment Project - Public Improvement (CDBG)," and 39-310, entitled "Columbia Redevelopment Project - Low and Moderate Income Housing Fund (CDBG)" and further authorizing the Auditor and Comptroller to allocate from the monies accepted in section 1 above to the newly created CIP Projects the sum of \$10.4 million, \$0.6 million, and \$1 million, respectively.

Section 3. That the Auditor and Comptroller be and he is hereby fully authorized to disburse the CDBG funds recited above in section 2 from the specified CIP Projects to the Redevelopment Agency for the purposes recited hereinabove.

Section 4. That the Auditor and Comptroller is authorized to accept from the Redevelopment Agency up to \$6 million

representing payment of principal and interest on Contributions to the Agency funded loans made to the Agency in the Marina Redevelopment Project, said funds to be appropriated to increase Contributions to the Redevelopment Agency Fund 10227.

Section 5. That the Auditor and Comptroller is authorized and directed to establish a new CIP Project No. 39-315, entitled "Marina Redevelopment Project - Public Improvements FY 88" and allocate the \$6 million recited above in section 4 to CIP Project No. 35-315.

Section 6. That the Auditor and Comptroller be and he is hereby authorized to disburse the above-recited \$6 million to the Agency from CIP Project No. 39-315, for the purposes specified hereinabove.

Section 7. That the City Manager be and he is hereby directed to record the above disbursements [as contributions or loans] to the Agency as interest bearing loans to be repaid as soon as practicable from tax increment or other revenues.

Section 8. That in the event the Agency issues bonds, notes, refunding bonds (including without limitation to the above-referenced refunding bonds) or other instruments of indebtedness of the Agency to carry out these redevelopment projects, including without limitation the above-referenced loans to the Agency, then any indebtedness of the Agency to the City, including any interest accrued thereon, shall be deemed not to be a first pledge of tax increment allocations received by the Agency pursuant to Health and Safety Code section 33670; and any indebtedness of the Agency to the City, including any interest

accrued thereon shall be subordinate to any pledge of tax increments to bondholders or the holders of other such instruments of indebtedness.

Section 9. That this ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in sections 15, 17 and 71 of the Charter of The City of San Diego.

Finally, the ordinance directs the disbursements to the Redevelopment Agency be recorded as Interesting loans to be repaid as soon as practicable from tax increment or other revenues and provides that in specified instances, the loans shall be subordinated.
