AN ORDINANCE AMENDING CHAPTER X, ARTICLE 3,
DIVISION 6, OF THE SAN DIEGO MUNICIPAL CODE BY
AMENDING SECTION 103.0601 RELATING TO THE
NORTH CITY WEST PLANNED DISTRICT.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 3, Division 6, of the San Diego Municipal Code be and the same is hereby amended by amending Section 103.0601 to read as follows:

SEC. 103.0601 AREA OF APPLICABILITY

The regulations contained herein shall apply in the North City West Planned District which is within the North City West area in the City of San Diego. The area to which the provisions of this division are applicable is shown on those certain Map Drawing Nos. C-670.2, C-671.1, C-676.2, C-670.3, C-683.1 and C-698, and described in the appended boundary description filed in the office of the City Clerk under Document Nos. 00-15634, 00-15635, 00-15883, 00-16048, 00-16074, 00-16187, 00-16349, 00-16379 and 00- 16975.

Sections 103.0600 through 103.0618 shall apply to each precise plan within the North City West Community Plan area when adopted by the City Council.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
