AN ORDINANCE AMENDING ORDINANCE NO. 0-16916 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENTS NO. 00-16916-1 AND NO. 00-16916-2, AS AMENDED AND ADOPTED THEREIN, BY ADDING TO THE PERSONNEL AUTHORIZATION OF THE CITY MANAGER'S DEPARTMENT (040), ONE (1.00) DEPUTY CITY MANAGER POSITION AND ONE (1.00) EXECUTIVE SECRETARY POSITION; AUTHORIZING THE AUDITOR AND COMPTROLLER TO INCREASE THE GENERAL FUND 100, CITY MANAGER'S DEPARTMENT (040) APPROPRIATION BY THE SUM OF \$93,368 [\$72,864 IN SALARIES AND WAGES, \$10,504 FRINGE BENEFITS AND \$10,000 IN NONPERSONNEL EXPENSE], SAID FUNDS TO COME FROM PREVIOUSLY UNANTICIPATED REIMBURSEMENT REVENUES FROM THE SEWERAGE UTILITY REVENUE FUND (41506), FOR THE PURPOSE OF FUNDING THE ABOVE AUTHORIZED POSITIONS, WITH RELATED NONPERSONNEL COSTS, FOR THE REMAINDER OF FISCAL YEAR 1988.

WHEREAS, the enormity of the matter of construction of new Secondary Treatment Sewerage Plant Works, extensive water reclamation facilities and considerable conversion and modification of the existing Point Loma plant to secondary treatment levels requires significant monetary expenditures and human resource application; and

WHEREAS, a Project Management Team has been established to interface with City staff in order to guide the long-term project through its various phases to completion; and

WHEREAS, it has been determined that in order to have a direct and concentrated connection in the City Manager's office

to the project between the Project Management Team and the Special Projects Division of Water Utilities, it is necessary to establish a Deputy City Manager position, with secretarial assistance, to provide the high-level interface necessary in connection with this project; and

WHEREAS, this action will amend the FY 1988 budget ordinance by adding two positions to the City Manager's Department; and

WHEREAS, the personnel and nonpersonnel expenses associated with the newly authorized sections will be reimbursed by the Water Utilities Department from the Sewerage Utility Revenue Fund (41506) to the General Fund 100, City Manager's Department (040); NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16916 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Documents No. 00-16916-1 and No. 00-16916-2, as amended and adopted therein, by adding to the personnel authorization schedule of the City Manager's Department (040), one (1.00) Deputy City Manager position and one (1.00) Executive Secretary position.

Section 2. That the Auditor and Comptroller be and he is hereby authorized and directed to increase the General Fund 100, City Manager's Department (040) by the sum of \$93,368 [\$72,864 for salaries and wages, \$10,504 for fringe benefits and \$10,000

for nonpersonnel expense], said sum to be reimbursed from previously unanticipated reimbursement revenues from the Sewerage Utility Revenue Fund (41506), for the purpose of fully funding the above newly authorized positions for the remainder of fiscal year 1988.

Section 3. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
