AN ORDINANCE AMENDING ORDINANCE NO. O-16916 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-16916-1 AS AMENDED AND ADOPTED THEREIN, BY INCREASING THE GENERAL FUND 100, NONDEPARTMENTAL EXPENSE (601), CITY OFFICE ACQUISITION PROGRAM (ORG. 117) BY THE SUM OF \$250,000 FOR THE PURPOSE OF FUNDING CONSULTANT STUDIES AND REQUIRED STAFF SUPPORT; AND DIRECTING THE AUDITOR AND COMPTROLLER TO TRANSFER SAID SUM OF \$250,000 FROM THE GENERAL REVENUE SHARING FUND (18014) CONTINGENCY RESERVE TO THE GENERAL FUND 100, NONDEPARTMENTAL EXPENSE, CITY OFFICE ACQUISITION PROGRAM (DEPT. 601/ORG. 117).

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16916 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-16916-1 as amended and adopted therein, by increasing the General Fund 100, Nondepartmental Expense (601), City Office Acquisition Program (Org. 117) by the sum of \$250,000, for the purpose of funding consultant studies and required staff support.


Section 2. That the Auditor and Comptroller be and he is hereby authorized and directed to transfer the above specified

sum of \$250,000 from the General Revenue Sharing Fund (18014) Contingency Reserve to the General Fund 100, Nondepartmental Expense, City Office Acquisition Program (Dept. 601, Org. 117).

Section 3. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
