AN ORDINANCE AMENDING ORDINANCE NO. 0-16916 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-16916-1, AS AMENDED AND ADOPTED THEREIN, BY INCREASING THE GENERAL FUND 100 APPROPRIATION BY THE SUM OF \$500,000; AUTHORIZING THE AUDITOR AND COMPTROLLER TO TRANSFER THE SUM OF \$500,000 FROM GENERAL REVENUE SHARING FUND (18014) CONTINGENCY RESERVE TO THE GENERAL FUND 100 UNALLOCATED RESERVE (605) TO BE USED FOR PURPOSES OF THE FUND; AUTHORIZING THE AUDITOR AND COMPTROLLER TO TRANSFER THE SUM OF \$250,000 FROM GENERAL REVENUE SHARING FUND (18014) CONTINGENCY RESERVE TO THE GENERAL FUND 100, NON-DEPARTMENTAL EXPENSE (60117) FOR NEW CIVIC CENTER DESIGN COSTS.

WHEREAS, in order to meet the provisions of the federal

Deficit Reduction Act relating to revenue sharing funds, the City

Council adopted Ordinance No. 16945 on September 29, 1987; and

WHEREAS, the ordinance authorized the appropriation of any fiscal year 1987 unappropriated monies in the general revenue sharing fund balance and any future general revenue sharing in excess of the estimated revenues to a contingency reserve (estimated at \$2 million); and

WHEREAS, subsequently, the City Manager has recommended to the City Council the transfer from the contingency reserve of \$750,000 for the Vernal Pools mitigation project and \$250,000 for the purpose of funding consultant studies and required staff support to prepare feasibility studies on alternative sites for a new civic center and the remaining funds of \$1 million can be expended by Council resolution for unanticipated expenses; and

WHEREAS, the General Fund Allocated Reserve provides for expenses or shortfall of revenues that cannot be anticipated at the time the budget is developed and the fiscal year 1988 appropriation was \$975,000; and

WHEREAS, unforeseen expenditures have reduced available funds to approximately \$25,000 and this action will serve to increase the General Fund Unallocated Reserve by \$500,000 in order to meet unanticipated expenditures which may arise during the remaining fiscal year; and

WHEREAS, in addition, an allocation of \$250,000 is recommended to augment funds for studies related to the new civic center with the balance of \$250,000 recommended to be retained in the revenue sharing reserve for unanticipated requirements during the balance of the year; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 0-16916 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1987-88 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 00-16916-1, as amended and adopted therein, by increasing the General Fund 100 appropriation by the sum of \$500,000.00.

Section 2. That the Auditor and Comptroller be and he is hereby authorized to transfer the aforesaid sum of \$500,000 from General Revenue Sharing Fund (18014) Contingency Reserve to the General Fund 100, Unallocated Reserve (605) to be used for purposes for which said reserve fund was created.

Section 3. That the Auditor and Comptroller be and he is further authorized to transfer the sum of \$250,000 from the General Revenue Sharing fund (18014) Contingency Reserve to the General fund 100, Non-Departmental Expense (60117) for new civic center design costs.

Section 4. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
