
RESOLUTION NUMBER R- 267379

BE IT RESOLVED, by the Council of The City of San Diego that the bid of SAN DIEGO KAWASAKI is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of six (6) POLICE MOTORCYCLES without electronic sirens (Kawasaki KZ1000-1987) at a cost of \$5,449.00 each, for a total cost of \$32,694.00; and four (4) each POLICE MOTORCYCLES with electronic sirens (Kawasaki KZ1000-1987) at a cost of \$6,019.00 each, for a total cost of \$24,076.00; for a total combined cost of \$56,770.00; terms net 30 days, plus sales tax, less trade-in allowance as follows:
