


RESOLUTION No. R-267386 (R- 87-963)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of JIMMY GILBERTS PUMPING is hereby accepted and the City Manager is hereby authorized to execute a contract for HARVESTING OF WATER HYACINTHS as may be required for a period of one (1) year beginning March 1, 1987 through February 29, 1988, at a cost of \$3.75 per cubic yard, for a total estimated cost of \$22,500.00; terms net 30 days, with an option to renew contract on a month-to-month basis for up to twelve (12) additional months, with a price escalation not to exceed 4% of bid price.
