
ADOPTED ON JAN 12 1987

BE IT RESOLVED, by the Council of The City of San Diego that the balance of the contract with GOULD HARDWARE & MACHINERY CO. for SMALL TOOLS, Section V, Shovels, and Section VII, Sockets and Socket Wrench Accessories, as may be required for the period August 1, 1986 through July 31, 1987, which was authorized by Resolution No. 266397, adopted on August 18, 1986, is hereby cancelled.

BE IT FURTHER RESOLVED, that the balance of the contract be awarded to the second low bidders as follows:

1. SEARS CONTRACT SALES for Section V, Shovels, as may be required for the period January 1, 1987 through July 31, 1987, for a total estimated cost of \$9,566.96 including sales tax; terms net 30 days, with an option to renew contract for an additional one (1) year period, with price increases not to exceed 15% of base year prices.
2. PETROU POWER for Section VII, Sockets and Socket Wrench Accessories, as may be required for the period January 1, 1987 through July 31, 1987, for a total estimated cost of \$25,992.99 including sales tax; terms 1% 20 days, with an option to renew contract for an additional one (1) year period, with price increases not to exceed 10% of base year prices.
