
BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF ADAMS SCHOOL PARK DEVELOPMENT, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on JAN 12 1987, and bearing official Document No. W.D. 118395, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF ADAMS SCHOOL PARK DEVELOPMENT.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$179,785.00 from CIP No. 29-461 ADAMS FIELD HOUSE REPLACEMENT PSD 600 (\$69,500.00 from Community Development Block Grant Fund 18519; \$100,000 from Revenue Sharing Fund 18013; \$772.60 from Park Service District Fund 11600 and \$9,512.40 from Park Service District Fund 15601) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
