BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$46,000 from Fund 30219.1, CIP No. 37-193 SAN DIEGO RESCUE MISSION - PUBLIC IMPROVEMENTS to supplement funds previously authorized by Resolution No. 264684, adopted on December 16, 1985, and Resolution No. 266474, adopted on September 8, 1986, is hereby reauthorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
