APPROVING MAP OF LA PLAYA TOWNHOUSES.

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by R. W. Forsberg, Licensed Land Surveyor, entitled "LA PLAYA TOWNHOUSES being a subdivision of a portion of the southeast quarter of Lot 124 of the Pueblo Lands of San Diego, said southeasterly quarter of Lot 124 being sometimes known as Lot 4, in Block 20 of beach lots of San Diego, according to the map thereof made by Cave J. Coutts in 1849, according to the map thereof made by C. H. Poole, in 1856, a copy of which said map was filed in the office of the County Recorder of San Diego County November 14, 1921 and is known as miscellaneous Map No. 35, together with a portion of the westerly 25 feet of San Antonio Avenue lying east of and adjoining said property as vacated and closed to public use on May 25, 1914 by Resolution No. 17359 of the common Council of The City of San Diego, all in the City of San Diego, County of San Diego, State of California," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the County Recorder of the County of San Diego, California.
