# RESOLUTION NUMBER R- 267403 ADOPTED ON JAN 12 1987

WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where for a period of five consecutive years the street to be vacated has been impassable for vehicular travel and during such period no public money has been expended for maintenance; and

WHEREAS, the property owners have requested the vacation of Old County Road Survey No. 80, all within the boundaries of proposed Penasquitos Park View Estates Unit No. 8 (T.M. 82-0700), to facilitate the development of their properties; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, the road to be vacated is not needed for present or prospective public street purposes; and

WHEREAS, those properties adjoining the road to be vacated will continue to have access; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That all of Old County Road Survey No. 80, located within the boundaries of proposed Penasquitos Park View Estates Unit No. 8 (T.M. 82-0700), as more particularly shown on Drawing

19735-D, on file in the office of the City Clerk as Document No. RR-267493, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

- 2. That the resolution shall not become effective unless and until the final subdivision map for Penasquitos Park View Estates Unit No. 8 (T.M. 82-0700) has been approved by City Council action. In the event that the final subdivision map for Penasquitos Park View Estates Unit No. 8 (T.M. 82-0700) is not approved by November 13, 1987, then this resolution shall become void and be of no further force or effect.
- 3. That the City Engineer shall advise the City Clerk of the approval of the aforementioned subdivision map, and that the City Clerk shall then cause a certified copy of this resolution, with Drawing 19735-D, attested by him under seal, to be recorded in the office of the County Recorder.
