RESOLUTION NUMBER R- 267406

APPROVING PARCEL MAP T.M. 86-0245.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by Jeffery B. Young, Registered Civil Engineer, entitled "Parcel Map T.M. 86-0245 being a subdivision of a portion of the north half of the southeast quarter of Section 6, Township 14 south, Range 3 west, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, together with portions of Via de la Valle and El Camino Real, as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Portions of El Camino Real and Via del la Valle, and said portion(s) of public street(s) are hereby declared to be portion(s) of public street(s) and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

That said Council hereby rejects as a dedication that portion of Parcel 1, marked "Reserved for Future Streets," as shown on the map, under the provisions of Government Code Section 66440.


That said Council hereby accepts on behalf of The City of San Diego, the easement(s) with the right of ingress and egress for

the construction and maintenance of drainage facilities, as granted and shown on the map within the subdivision.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said parcel map and that said portion(s) of public street(s) are accepted on behalf of the public as heretofore stated that said Council has rejected a portion of Lot 1 marked "Reserved for Future Street"; together with the easement(s) with the right of ingress and egress for the construction and maintenance of drainage facilities, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the County Recorder of the County of San Diego, California.
