WHEREAS, section 22.0101 of the San Diego Municipal Code establishes Permanent Rules of the Council; and

WHEREAS, Rule 1 thereof governs the hours of meetings and establishes the times and procedures to be followed when scheduling meetings of the City Council; and

WHEREAS, Rule 1, subsection (d) was amended by Ordinance No. O-16064 (New Series), effective October 24, 1983, to provide for night Council meetings on a quarterly basis, the date, time and location thereof to be established by resolution of the Council; and

WHEREAS, it is now necessary to resolve, pursuant to the provision of Rule 1(d), the date, time and location of the above cited evening Council meeting; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that pursuant to the authority and provisions of Rule 1(d) of the Permanent Rules of the Council, set forth in section 22.0101 of the San Diego Municipal Code, it is hereby declared that the quarterly night City Council meeting shall be scheduled for Tuesday, January 27, 1987, and shall be conducted at the University City High School Auditorium, 6949 Genesee Avenue, San Diego, California, 92122, for the purpose of discussing the update of the University Community Plan, said meeting scheduled to commence at 7:00 p.m.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to post and publish, as necessary, the notice of such meeting with the date, time, and location thereof and make necessary preparations and arrangements therefor.
