ADOPTED ON JAN 12 1987

WHEREAS, in 1976, the City Council established the San Diego Chamber of Commerce Motion Picture and Television Bureau to promote our City to the film industry; and

WHEREAS, it now effectuates an economic impact of over \$8 million annually; and

WHEREAS, the Bureau creates hundreds of jobs for local actors, extras, and craft service people; and

WHEREAS, the Bureau was selected as the "most effective City Film Commission" in the country by Executive Producers; and

WHEREAS, the United States Census Bureau has documented a 944% increase in production related services in San Diego since the establishment of the Bureau; and

WHEREAS, for the first time in its fifty-three year history, the industry's "bible," Daily Variety, selected San Diego for a full-length feature issue; and

WHEREAS, the Bureau coordinates several hundred productions in San Diego County each year; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the San Diego Chamber of Commerce Motion Picture and Television

Bureau be and it is hereby appointed as San Diego's official liaison to the motion picture and television industry.
