
ADOPTED ON JAN 12 1987

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to authority conferred by and in accordance with the provisions of Section 85.02 of the San Diego Municipal Code, a TRUCK PARKING PROHIBITED ZONE, restricting the parking of vehicles with gross vehicle weight rated capacity of over 10,000 pounds, be and the same is hereby established on the 30TH STREET BETWEEN IRIS AVENUE AND A POINT 400 FEET NORTH OF DEL SOL BOULEVARD.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same is hereby authorized to be made on said street, and the regulations hereinabove imposed shall become effective upon the installation of such signs.
