
RESOLUTION NUMBER R- 267447

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a First Amendment to Lease Agreement with MARRON VALLEY ENTERPRISES, INC., a California corporation, adjusting the annual rent from \$16,000 to \$9,600 for 2,500 acres of land situated in Marron Valley, and which First Amendment also changes the Lessee's right to renew the lease from twentyfive (25) years to ten (10) years, under the terms and conditions set forth in that First Amendment to Lease Agreement on file in the office of the City Clerk as Document No. RR- 267447.
