RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ACCEPTING AND APPROVING THE REPORT ON THE SAN DIEGO POLICE DEPARTMENT HUMAN RELATIONS TRAINING PROGRAM AND AUTHORIZING THE IMPLEMENTATION AND FUNDING THEREOF.

WHEREAS, in July 1986 the San Diego Police Department's Task Force on Human Relations Training was established to assist the Citizens' Advisory Board on Police/Community Relations in designing and implementing a new human relations training program; and

WHEREAS, the Task Force prepared a report setting forth the background, research, analysis and recommendations pertaining to the development of a new human relations training program; and

WHEREAS, Phase I of the implementation of the training program requires funding during fiscal year 1986-1987 from unallocated reserves in the amount of \$156,900; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Report on the San Diego Police Department Human Relations Training Program, filed in the office of the City Clerk as Document No. RR-267450, be and the same is hereby accepted and approved.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to implement the Police Department's Human Relations Training Program as set forth in the Report.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer the amount of \$156,900 from General Fund 100, Unallocated Reserve (605) to Department 11000, Program Element 11610 to provide necessary funds for Phase I of the Police Department's Human Relations Training Program.
