


RESOLUTION No. R- 267458 (R87-1293)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the offer of NASH ENGINEERING CO. is hereby accepted and the City Manager is hereby authorized to execute a contract for REPAIR OF TWO NASH PUMPS at a cost of \$10,133.00 each, for a total cost of \$20,266.00; terms net 10 days, plus a 10% contingency to cover unanticipated repairs.
2. That the provisions of the Municipal Code Section 22.0504, which requires that requests for goods and services of a value of \$10,000 or greater be advertised, are hereby waived.
